

# 4.TRUSTEES TO RENDER TRUE ACCOUNTS: -

- d) To invest and keep invested the trust fund either in the purchase or mortgage of immovable property including a flat or in units, shares, stocks, or debentures permitted by the Indian Trust Act, 1882 or any other statute, or deposit with banks, firms and to alter, vary or transpose such investments from time to time as the trustees may in their discretions think fit for others of the same or different nature.

### 8. NUMBER OF TRUSTEES: -

Majority will decide all matters.

Any resolution passed without any meeting of the trustees but by circulation thereof and evidenced in writing under the hands of two-thirds of the trustees shall be as valid and effectual as a resolution duly passed at a meeting of the trustees.

## 12. LOCATION OF THE TRUST OFFICE: -
